



Limited LIFETIME Warranty

Prefinished Staining Products factory finished PPG InterMix coated products are warranted to the original purchaser for the **LIFETIME** of the product. Under normal conditions and care our finish is warranted not to:

- Discolor due to chalking
- Peel, blister, or crack
- Erode and expose the substrate
- Discolor due to yellowing
- Discolor due to excessive fade

If the factory coated siding is found to be defective from one of the specified conditions above, Prefinished Staining Products will:

- Provide the necessary amount of coating needed to repair the area determined as defective from any of the specified conditions listed above.**
- Prefinished Staining Products, as it's sole liability and in lieu of any direct, indirect or consequential damages will, during the first year after coating, reimburse the homeowner for the reasonable fees for labor (an amount not to exceed \$1.00 U.S. per square foot). The maximum fees for labor will be reduced by 6.67% per annum for the 2nd through 15th years such that after the 15th year Prefinished Staining Products sole liability will be for replacement coating only.**

Warranty Limitations

This warranty does not cover cracking, peeling, or blistering which may result due to inadequate ventilation or improper construction techniques, and specifically excludes cracking, peeling, blistering and efflorescence caused by defective primer or inadequate primer application as supplied/applied by siding manufacturer. This warranty does not apply to failure caused by excessive expansion, contraction, or other movement of the substrate. This Warranty does not apply to damage or failure caused by the breakdown of the underlying substrate; defective substrate or primer; falling objects; faulty or improper storage and installation (as defined by industry standards); lack of proper construction or maintenance, accidental damage; structural defects; fire, lightning, hurricane, tomado, windstorm, earthquake, hail, or other acts of God; harmful chemicals (including harmful cleaning compounds); surface deterioration due to pollution; misuse; abuse; vandalism; mildew accumulation; scratching; abrading; or misuse/abuse of the factory-finished product after application. This product is warranted against excessive fading as defined by industry standards.

Prefinished Staining Products (here in after referred to as the "Warrantor") obligations under this Warranty shall in no event exceed the purchase price of the original product. Any product found to be unsatisfactory prior to installation, for any reason, must not be installed and should be returned to the dealer where it was purchased for replacement product. The Warrantor will not be responsible in any way for labor or material if defective or unacceptable product is installed. The warrantor shall not be liable for any consequential or special damages, or for other expenses such as accessories (building paper, sheathing, fasteners, caulking, etc.) which may arise in connection with this Warranty.

THIS WARRANTY IS EXPRESSLY MADE IN LIEU OF ANY AND ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE AND ALL OTHER OBLIGATIONS OR WARRANTIES ON THE PART OF THE WARRANTOR FOR DAMAGES INCLUDING BUT NOT LIMITED TO CONSEQUENTIAL OR SPECIAL DAMAGES.

CLAIM PROCEDURE: Upon discovery of a possible defect/failure, a claim must be filed immediately. The covered person must provide photographs of the defective product and allow Prefinished Staining Products or their representatives to review the premises, take photographs, and collect samples of the warranted product.
